**Dear customers,**

We would like to inform you that, as of 20.08.2026 UniCredit Bulbank AD introduces changes in the Tariff for fees and commissions of UniCredit Bulbank for Individuals, Section III. Transfers, expanding the scope of possibilities for executing instant payments to banks in the SEPA area, both within the European Economic Area (EEA) and outside the EEA, where the respective bank offers such services, as follows:
